# Michigan FASD Task Force Minutes August 21, 2014

### **State FASD Discussions**

Charlyss reported on the state FASD workplan. She is working on the part that targets youth in transition ages 16-24. Three pilot projects are being proposed. One would work with youth in the juvenile justice system in Kalamazoo with a collaboration of the court and CMH. A second would identify transition age youth in school in the UP. A third would use a peer support model for adults who have FASD and need some support in Macomb County, a collaboration of CMH and the Arc of Macomb. Charlyss asked for ideas to support the 3 groups to be sent to her (websites, articles, etc). She is hoping that the pilots will be funded and begin in October of 2015.

Joan offered to check with Deb Kimball to see what the status of the Governor's Proclamation and the new FASD PSA.
